TRADING STATEMENT

The Board of Directors of British American Tobacco (Zambia) Plc (“the **Board**”) wishes to advise the Shareholders that for the year ending 31 December 2024, the basic earnings per share is 74% higher than that of the corresponding period last year for the Company.

This increase is due to higher operating profit resulting from increased revenue driven by optimal pricing strategy and execution excellence implemented during the period, which was partially offset by higher cost of operations mainly due to local currency devaluation.

The Company expects its audited results for the year ended 31 December 2024 to be released on SENS and published in the local press on or about 11 March 2025. Accordingly, shareholders are advised to exercise caution when dealing in the Company’s securities until publication of the results.
