Market Commentary

The Lusaka Stock Exchange All Share Index (LASI) excluding ZCCM-IH **gained** by **1.89%** w-o-w to close at 17,485.89 points.

In terms of turnover, the market closed at ZMW 8.14M (USD 302.77k) over 950.51k shares traded, marking **a significant decrease** to last week's ZMW 12.97M (USD 482.69k) on 1.65M shares. The highest turnover contributor this week was ZNCO at 35.20%.

No units traded for the market's listed REIT REIZUSD this week. Furthermore, no price action was recorded this week.

ZMFA was the lead price gainer on the exchange recording an increase of ZMW **2.00** (USD 0.07) or roughly **33.33%** to close at ZMW 8.00 (USD 0.30). On the loss side, ATEL dropped ZMW **-0.01** (USD 0.00) or approximately **-0.01%** closing at ZMW 89.49 (USD 0.30).

On the foreign exchange market, the Kwacha **Depreciated** against the following: ZAR (2.11%), USD (1.35%), GBP (1.29%), and EUR (0.70%).

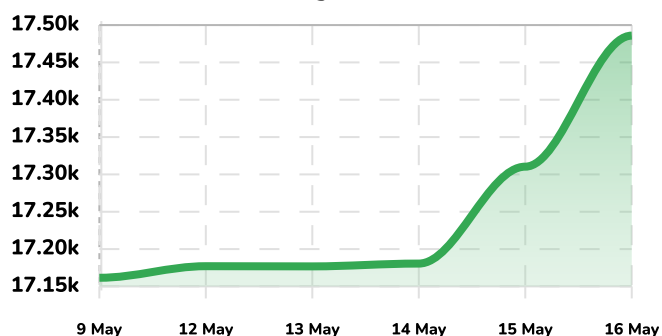

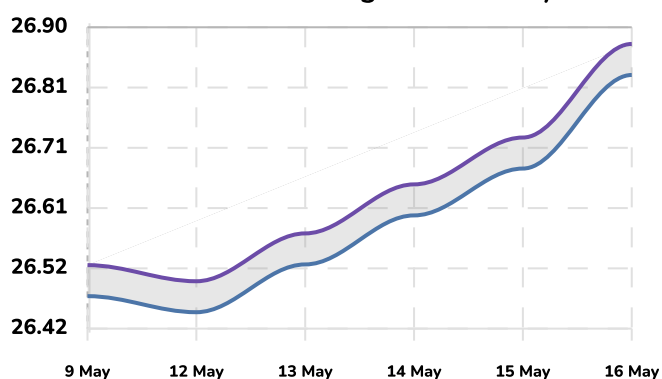

Zccm Cautionary Arbitration Proceedings

Zccm investments holdings plc ("zccm-ih") announced confidential arbitration proceedings initiated by trafigura pte limited ("trafigura") under london court of international arbitration rules 2020 due to a guarantee signed in 2021. The arbitration stems from a demand for payment related to a zmw1,663 million (us\$100 million) prepayment agreement between trafigura and konkola copper mines plc, where zccm-ih is a shareholder. Zccm-ih is contesting the claims and advises shareholders to exercise caution regarding company securities until further updates are provided.

Zccm Further Cautionary

Zccm investments holdings plc (zccm-ih) issued a cautionary announcement on may 16, 2025, regarding new developments, following a previous announcement on march 31, 2025. The company warns that the full impact of these developments is still being assessed and may materially affect the price of its securities. Shareholders are advised to exercise caution and seek professional advice before dealing in zccm-ih securities.

Stanchart Further Cautionary

Standard chartered bank zambia plc (scbz) announced on may 13, 2025, that it is still exploring options for the sale of its wealth and retail banking (wrb) business, following a previous announcement on november 27, 2024. The company, with registration number 6525 and share code scbz (isin: Zm0000000094), is listed on the lusaka securities exchange. investors are advised to exercise caution and consult advisors regarding scbz securities.

Reiz Lewanika Cautionary

Real estate investments zambia plc (reiz) issued a cautionary notice on may 9, 2025, regarding an ongoing court appeal related to the lewanika mall and a dispute involving forli limited and the city of lusaka football club. The court of appeal granted a stay of execution of the high court judgment from december 9, 2024, pending the appeal's determination. There is no immediate impact on lewanika mall or reiz's business, and further announcements will be made as material developments occur.

Airtel Change In Directorate

Airtel networks zambia plc announced the expiry of ms. Monica musonda's term as director and chairperson on may 1, 2025. The board appointed ms. Lynda mataka as the new chairperson and mr. Hamish chipungu as a director, both effective may 1, 2025. this announcement, approved by the lusaka securities exchange and the securities and exchange commission, includes information that may be price sensitive.

Changes to GRZ T-Bill yields

The 273D T-Bill rose 0.01% to close at 13.25%.

Changes to GRZ Bond yields

The 3Y bond dropped -0.02% to close at 16.50%. The 5Y bond dropped -0.02% to close at 16.80%. The 7Y bond dropped -0.01% to close at 18.49%. The 10Y bond dropped -0.02% to close at 19.00%. The 15Y bond dropped -0.02% to close at 20.00%.
