The LuSE All Share Index closed at 15,369.04 points due to no changes in stock prices.

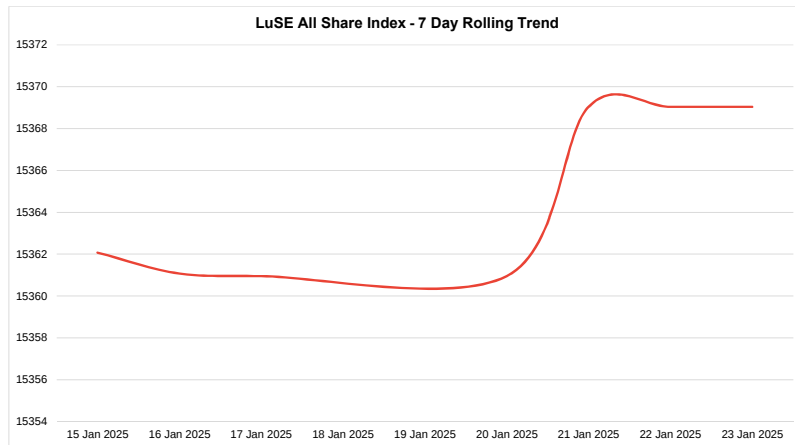
